

Overview of Rates & Revenues

Proposed FY 2019 and FY 2020 Rates, Fees and Charges


- Proposed rates meet spending levels in the FY19 operating budget and FY18 27 Capital Improvement Plan, previously approved by the Board
- The proposed multi-year rate proposal covers FY 2019 and FY 2020
 - ◆ The water and sewer rate increases are 13% for FY 2019 and 5% for FY 2020.
 - The Proposed Clean Rivers Impervious Area Charge (CRIAC) of \$23.00 per ERU in FY 2019 and \$25.58 per ERU in FY 2020. CRIAC decreased from projected \$28.41 in FY 2019 to \$23.00 per ERU per month
 - The Customer Metering Fee and Water System Replacement Fee (WSRF) will remain the same as in FY 2018
- Combined rate increase for water, sewer and CRIAC for average household customer lowered from 6.1% forecasted last year to 5.9%


FY 2019 vs. FY 2020 Operating Revenues

Revenue Comparison by Customer Class

- Total revenue is projected to increase by \$23.0M or 3.7% for FY 2019 and \$36.3M or 5.6% for FY 2020
- Retail revenue is projected to increase by \$21.7M or 4.4% for FY 2019 and \$30.7M or 5.9% for FY 2020
- Wholesale revenue is projected to decrease by (\$0.6M) or -0.7% for FY 2019 and increase by \$2.4M or 3.0% for FY 2020

FY 2018 Cost of Service Study Findings

- Every three years DC Water conducts a Cost of Service Study for the Water and Sewer rates, and the Clean Rivers Impervious Area Charge (CRIAC) to update actual and projected expenditures to ensure that these charges are appropriately recovering costs
- The proposed CRIAC and Water and Sewer rates include actual and projected debt service costs associated with those programs. While total debt service costs have not changed significantly from previous forecasts, the debt service costs associated with the Clean Rivers program are less than previously forecasted
- The revenue collected from the Water System Replacement Fee, designed to fund the annual costs of 1% of DC Water's water service renewal and replacement program, is fully allocated to the Water utility's revenue requirements, resulting in a decrease to Water volumetric charges
- These two recommendations cause shifts in the cost structure, and subsequent rates, though average household customers will see only minimal changes



Public Outreach and Comments

- The Notice of Proposed Rulemaking for the proposed rates was published in the DC Register on March 16, 2018
- Public comments were received during the public comment period that lasted from March 16, 2018 to June 11, 2018
- DC Water held eight town hall meetings, one in each ward, between March 29, 2018 and April 24, 2018
- The DC Retail Water and Sewer Rates Committee received comments during the Public Hearing on May 9, 2018
- DC Water testified before the City Council on May 22, 2018 on the CRIAC
- DC Water and the District officials continue to hold ongoing discussions on a one-year affordability program

Summary of Public Comment

- Consider the impact of higher rates and fees on low-income seniors
- Provide CRIAC charges exemptions for churches and cemeteries
- Re-consider whether DC Water will need a 13 percent rate increase in FY 2019
- Consider charging the District for its own impervious surface area, which would provide as much as a 35 to 40 percent reduction to the CRIAC
- Examine ways to minimize the need for increased government fees and ensure that they do not overwhelm ratepayers
