

### Proposed Revisions To The Business Development Plan - Review

#### Why The Proposed Changes

- Board Requirement
- In response to the 2017 Audit (RSM) Findings
- To conform with existing (federal) guidance and practices
- In response to requests and suggestions made by DC Water staff and contractors

#### **Development Process**

- > Took a year to complete
- Multiple Departments involved in the process
- Over 80 firms and organizations engaged



#### Proposed Revisions To The Business Development Plan - Review

#### Summary of Changes

- Local Small Businesses given preference with Micro Purchases and Simplified Acquisitions
- Limit Fairshare Objectives to projects clearly identified as grant funded or submitted to the EPA for funding
- Creates a new DBE/WBE program for non-federal Goods, Services, and Construction projects over \$1M
  - Tri-Annual Goal Setting for DBE and WBE utilization
  - Project Specific Goal Setting
  - Enhanced Outreach Requirements
  - District Based "Certified Business Enterprises" can now be counted on DC Water projects.
  - Allow Prime Contractor participation to be counted towards Goals
- Confirms DC Water's Program is not race based Social and Economically Disadvantaged



#### Proposed Revisions To The Business Development Plan - Review

#### Summary of Benefits

- Gives Greater Clarity over the expectations of DC Water
- Aligns with current Federal and local standards and practices
- Potential for Increased Certified Firm Participation Particularly CBE's and WBE's
- Strengthens DC Water's Capacity Building Efforts
  - Mentor-Protégé standards
  - Forecasting and Information Sharing
  - Education and Outreach
- Dotted line reporting directly to General Manager
- Supported by Primes, Subs, Agencies, and Organizations
- Greater Flexibility and Control given to DC Water
