

# LPRAP

## Helps replace private lead pipes for FREE or at a 50% discount.



Older homes built before the 1980's likely have a lead service line – the pipe that connects the city water supply to your household plumbing.

For decades, DC Water has been replacing lead pipes in the city. At some homes, the portion in public space was replaced with copper, but lead remains in private space.

Your home has a lead pipe in private space. If you believe our records are incorrect, please contact lead@dcwater.com.

#### Why should I apply for LPRAP?

Lead can cause serious health problems if too much enters your body from drinking water or other sources. It can cause damage to the brain and kidneys and can interfere with the production of red blood cells.

The greatest risk of lead exposure is to infants, young children, and pregnant women. Scientists have linked the effects of lead on the brain with lowered IQ in children.

Adults with kidney problems and high blood pressure can be affected by low levels of lead more than healthy adults.

Landlords must disclose the presence of lead pipes to tenants (Code of the District of Columbia §42-3271). LPRAP assists with cost of removal.

#### **Do I qualify for LPRAP?**

Every eligible property owner can receive a 50% discount, regardless of income, up to \$2,500. Lower income residents will qualify for 100% coverage depending on household size and income.

Income verification documents are not required for the 50% discount. However, the 100% coverage will require these documents.
