



**Lead and Copper Compliance Report  
July through December 2008**

In a letter dated September 25, 2008, the Environmental Protection Agency, Region III Office, clarified its instructions to DC WASA regarding the elimination of the 10-minute pre flush instruction on the chain-of-custody form (COC). DC WASA revised the COC based on this clarification resulting in two COC's used for LCR compliance during this monitoring period. In the letter, Region III also requested DC WASA to note locations of samples taken with each set of instructions. Appendix A in this report lists the LCR first draw sample used for LCR compliance and the dates the samples were collected. A total of 44 first draw samples were collected between July 29, 2008 and August 28, 2008 using the COC instructions that included the 10-minute pre flush. The remaining 68 first draw samples collected between September 30, 2008 and November 20, 2008 used the revised COC that eliminated this instruction.
