

DC Water Rates for FY 2018

DC Water's new rates begin on October 1, 2017. The Authority carefully assessed the financial needs of the organization to determine the revenue needed to deliver critical water and sewer services to its customers. It is always a balancing act, allocating the funding for much-needed infrastructure work and meeting federal mandates for environmental protection while trying to keep customer rate increases at a minimum.

The DC Water Board of Directors approved the rate increase for Fiscal Year 2018. The FY2018 rates are to the right.

DC Water has several programs to assist qualifying customers:

- The Customer Assistance Program (CAP) is a discount program providing eligible customers with up to 400 cubic feet (about 3000 gallons) of water and sewer service at no charge. The average CAP customer also receives a 100% discount on the Water System Replacement Fee (WSRF) and a 50% credit off of the Clean Rivers Impervious Area Charge for a combined monthly savings of up to \$59.13. The Department of Energy and Environment determines eligibility based on federal low-income guidelines. Please call DOEE at (202) 673-6700 for more information.
- Serving People by Lending a Supporting Hand (SPLASH) is a program to assist families and individuals facing hardships with maintaining critical water and sewer services. Please call (202) 354-3600 for more information.


DC Water's Mobile App Makes Paying Bills Easier

The images below are for Google Play; Apple App Store download and installation follows the same steps, but the screenshots differ.


Search
