





### FY 2016 Recommendations

#### Proposed Recommendations for Goods and Services:

#### I. Overall

- 1) Generate a Procurement construction and services forecast at the beginning of each fiscal year.
- 2) Establish links to certifying agencies on the DC Water Website.
- 3) Implement a process to determine the eligible dollars for participation.
- 4) For Discretionary projects- Update the certifying authorities recognized for LBE and LSBE certification
- 5) For EPA funded projects Update the definitions for Minority Business Enterprise (MBE) and Women Business Enterprise (WBE) to align with current EPA definitions
  - (Current) Minority Business Enterprise (MBE) for the purpose of the federal mandated program and fair share objectives, at least one of the following:
    - 1. A business which is certified as socially and economically disadvantaged by the Small Business Administration; or
    - 2. A business which is certified as a minority business enterprise by a state or federal agency; or
    - 3. An independent business concern which is at least 51% owned and controlled by minority group member(s).

(Revised) Minority Business Enterprise (MBE) – as prescribed by 40 CFR Part 33.103 - for the purpose of the federal mandated program and fair share objectives, means a Disadvantaged Business Enterprise (DBE) other than a Small Business Enterprise (SBE), a Labor Surplus Area Firm (LSAF), a Small Business in Rural Areas (SBRA), or a Women's Business Enterprise (WBE).

- For EPA funded projects- update the reporting requirements to align with current EPA requirements.
  - C. Reporting

DC Water will implement a procedure for monitoring contractor compliance with MBE/WBE requirements and will submit <del>quarterly</del> MBE/WBE utilization reports to the EPA as required by 40 CFR Part 33.

#### II. Micro-Purchases

- > Develop a formal process to identify certified firms for P Card use (Request for Information/Request for Qualifications) and modify the Procurement Manual to require the use of these firms (to the extent possible).
  - (Add) 32.2.4 Purchase Card Purchases (Under \$5,000)
    To the extent possible, purchases made with DC Water Purchase Cards will be made with certified LBEs and/or LSBEs. The Department of Procurement is responsible for identifying certified LBEs and LSBEs for participation.



#### **III. Small Purchases**

- Update the simplified acquisitions process for procurements under \$100k to focus on certified LSBE firms (consistent with Section 32.2.2 of the Procurement Manual).
  - Annually, through the use of competitive practices (RFP/RFQ) develop a short lists of firms to provide quotes for small purchases
  - o Extend preference points allocation to small purchases

#### **IV. Large Discretionary Procurements**

- In order to encourage greater diversity of certified firm participation, develop and implement "Good Faith Efforts" requirements for discretionary projects including a "Good Faith Efforts Checklist and best practices which would be included in all LSBE solicitations and posted to the web.
- Include certified contractor information for primes and subs, as applicable, on DC Water fact sheets. Information would include whether or not the firm conducted any outreach to the LSBE community and the overall level of LSBE participation if any.
- > Provide contact information for compliance on DC Water's Procurement web page.
- For G&S awards over \$1M, require the prime to submit an updated sub-contracting plan for LSBE participation for each Option Year exercised or modification.
- To encourage greater participation and partnering opportunities, Procurement should hold more pre-bid/pre-proposal meetings for goods and services and include time for networking.
- To reduce the possibility of a pass-through, the LSBE Program should be updated to award preference points based on the product or service authorized by the certifying authority.
- Set bi-annual LSBE goals for Goods and Services based on an accepted goal setting process and consistent with area jurisdictions.
- > Develop prompt payment language for LSBE firms similar to those under the EPA program.

### **Proposed Revisions**

Projects to be identified by one of three categories:

- 1. Federally Funded Projects funded or supported by EPA Assistance.
  - Clean Water Act
  - Safe Drinking Act
- 2. Open With Preferences
  - Large Goods and Services
  - Simplified Acquisitions
- 3. (New Program) DC Water DBE Program
  - Architecture and Engineering Projects
  - > Clean Rivers
  - > Large non-funded/non-eligible construction projects

New Program "must haves":

- > Program does not adversely impact competitiveness (does not chase bidders away).
- > Program does not discourage firms to bid/subcontract on EPA funded projects.
- > No undue cost burdens on contractors/subcontractors.
- > Can be monitored effectively with existing resources.
- Be consistent with other area programs.

**DC Water DBE Program** 

Specifics include:

- Disadvantaged Business Enterprise Participation Annual Goal (DC Water Defined)
- Women Owned Small Business Participation Annual Goal (DC Water Defined)
- Good Faith Efforts to achieve the Goals (DC Water Defined)
- Program is not Race Based
- Board review of Goals every three (3) years

- > Allow Prime Contractor participation to be counted towards Goals
- > Expand the certifying authorities recognized for DBE and WBE
- > Preference given for firms in user jurisdiction
- > Define Commercially Useful Function (Follow the fed 30% definition)

#### Requirements

- Development of new "fairshare" program language
- > Availability Analysis Initial and Every three (3) years
- Clearly define the certifications accepted by this program.
- > Define Good Faith Efforts. Develop standards for local outreach.

#### Pros

- Clarifies the goals and expectations for certified firms
- Follows established protocols
- Contractor familiarity
- Increases potential WBE participation
- > DC Water Projects are achieving DBE and WBE participation (particularly with an expanded definitions)
- > Regulation structure is already in place (not reinventing the wheel)

  - o DC water receives an estimated \$3M annually
- Grants covers up to 55% of the District's share of the project's costs

DC Water Grant Request Process

- In July the DC Water EPA Grants Coordinator pulls a list of projects from an approved CIP list that are scheduled to start the next fiscal year. This list is sent to DDOE for approval of grant funding.
  - DC Water can elect to submit a previously funded active project for consideration in lieu of a new list.
  - This grant stream supports projects inside the gate, which are large and multi year.
- > Clean Water grants are competitive (Green Reserve Requirement).
  - Competition is with eligible DC Based Organizations (municipalities, nfp's).
- > DDOE ranks the list of proposed projects and proportions the grant money accordingly.
- List approved by DDOE generally 60-90 days after submittal (Approved list).
- > All projects are ranked and approved for funding by DDOE. This is the basis for identifying the DC Water Projects as "EPA eligible".
- > In the event there is EPA funding available beyond the fiscal year appropriation, the remaining approved projects may received grant assistance.


#### Safe Drinking Water Act

- > EPA awards Safe Drinking Act grants every two (2) years.
  - o DC water receives an estimated \$8.5M annually (list provided every two years)
- Grants covers up to 80% of a project's costs

DC Water Grant Request Process

- In July the DC Water EPA Grants Coordinator pulls a list of projects from an approved CIP list scheduled to start in the appropriate fiscal year. This list is sent to the EPA for approval of grant funding.
- Projects are sorted by construction start date.
- > DC Water adds the current list projects to the "rolling" list of projects previously submitted for consideration.
  - $\circ~$  DC Water can elect to use the grant money continuously fund a multi year active project.
- List approved by EPA generally 60-90 days after submittal (Approved list).
- > All projects are approved for funding by the EPA. This is the basis for identifying them as "EPA eligible".
- > The EPA then indicates how much funding Dc water can expect. (The \$8.5 Million received on average is generally applied to one or two projects).
- The EPA Grants Coordinator identifies which projects will use the grant funds. The decision is generally based on the project costs and start date. Examples:
  - $\circ~$  A project that begins on October 1 and costs \$20M will be allocated the entire \$8.5M grant.
  - A project starts Oct 1 and costs \$5M will receive a portion of the grant, and the next project will receive the remainder.
- > In the event there is EPA funding available beyond the fiscal year appropriation, the remaining approved projects may received grant assistance.
- > A list must be submitted evert two (2) years.


#### **BLUE DROP – DC WATER'S BOARD GOVERNANCE (cont.)**

As the Member of Blue Drop, LLC, there are certain areas where the DC Water Board should exercise oversight of the activities of Blue Drop, including:

- Formation and Dissolution
- Review of Financial and Business Affairs
  - Per D.C. Code §29-804.10(2) A Member may obtain from the company, and inspect and copy, full information regarding the activities and affairs, financial condition, and other circumstances of the company as is just and reasonable
    - Powerful tool to exercise oversight
- Role of Member Rep
  - Manage communication of Member Rep
- Conduct regular reviews of Blue Drop compliance with the Stated Purposes and Mission (Reasonable Business Judgment)
  - Encourage appropriate reporting and metrics
- Regarding contracts between DC Water and Blue Drop
  - Recognize Blue Drop is a separate corporate entity; Protect against alter-ego relationship; Ensure contracts are arms' length transactions
- Member Consent May Be Taken Without a Meeting and the Member May Appoint A Proxy to Consent or Act on Behalf of the Member (*e.g.*, DC Water's Member Representative) [D.C. Code §29-804.07(d)] (George Hawkins appointment; see slide 4)








- Bloom
  - Marketing and sales agreement between Blue Drop and DC Water.
    - \$5/ton marketing fee to Blue Drop.
    - Short-haul transportation cost reimbursed.
    - Revenue stays with Blue Drop; DC Water saves on land application.
  - On track to meet target of 10,000 tons diverted from land application in FY 2017.
  - Largest customer = Maryland tree nursery.
  - Marketing fee to Blue Drop = \$50,000.
  - Sales revenue to Blue Drop = \$10,000 or less.
  - Cost savings to DC Water = \$200,000.



- Bloom
  - Ongoing, constructive conversations with Maryland Department of the Environment on opening up new markets for Bloom via enforcement discretion.
  - Virginia permit still TBA.
  - Pennsylvania and District of Columbia permits in hand.
  - Bloom updates presented regularly to EQ&Ops committee and Blue Plains Regional Committee.

- Estimated FY17-19 Bloom avoided costs to DC Water \$780k-2.2M.
