Hello Maureen,

My staff reviewed the December 31, 2025, request by DC Water to invalidate lead and copper results from site 658 E St SE, collected during the July to December 2025 monitoring period. After processing the samples, DC Water discovered that proper sample collection methods were not followed. The residence indicated leaks in their plumbing at the time of sampling and therefore did not adhere to the minimum required stagnation period prior to sample collection on October 2, 2025.

As stipulated in 40 CFR 141.86(f) (July 1, 2020), the primacy agency may invalidate a lead or copper tap sample meeting the conditions specified therein. EPA believes the analytical results should be invalidated because the minimum stagnation time of six hours, required by 40 CFR 141.86(b)(2) (July 1, 2020), was not met. Therefore, as the sample collected from 658 E St SE on October 2, 2025, did not meet the required minimum stagnation period of six hours prior to sample collection, EPA approves the request to invalidate this sample. DC Water shall not include these results in its 90th percentile lead and copper level calculations for the July to December 2025 compliance monitoring period. As DC Water receives LCR compliance samples from sites in its approved LCR sampling plan, EPA again strongly recommends that staff review and verify every customer-submitted document accompanying each sample upon receipt to prevent the processing of any improperly collected samples and subsequent invalidation requests.

Based on DC Water's approved 2025 Lead and Copper Monitoring Plan, the loss of the October 2025 sample from this location does not appear to impact the minimum number of required samples sites per 40 CFR 141.86(c) (July 1, 2020); please notify our office if incorrect.
